ARTICLE 4 1 2 **UFF PRIVILEGES**

- 3 Use of Facilities and Services. Subject to the rules, regulations and policies of the Board and 4.1 4 the University, the UFF shall have the right to use the University's facilities for meetings on 5 the same basis as they are available to Affiliated Organizations. (See FPU-1.003 Use of University Facilities and Properties, amended on Dec. 6, 2017.) The UFF will not be charged 6 7 for facility space usage or associated processing fees.
- 8 4.2 Faculty Assembly Meetings. The UFF shall have the right to address the Faculty Assembly 9 when properly recognized by the Chair for the purpose of making announcements regarding 10 collective bargaining or any item on the Faculty Assembly's agenda that affects the wages, 11 hours, or other terms and conditions of employment of bargaining unit members. Such 12 recognition shall occur in the same manner for the UFF as it does for other organizations (i.e. Student Government Association) seeking to address the Faculty Assembly for the purpose 13 14 of making public comments.
- 15 4.3 Other Meetings. UFF may invite Employees to UFF events such as lunches, picnics, 16 gatherings, dinners, and other events as determined by the UFF.
- 17 New Employees. UFF shall receive notification three times per year (prior to the opening of 4.4 18 the fall semester, prior to the opening of the spring semester, and immediately at the 19 conclusion of the spring semester) of new employee hires including rank and academic year 20 salary. UFF shall be given the opportunity to speak annually at the fall faculty orientation for 21 ten minutes.
- 22 4.5 Bulletin Boards. UFF shall have the right to post notices to employees of activities and matters 23 of concern to employees on non-electronic bulletin boards located in areas as mutually agreed upon by UFF and the University. UFF is responsible for removing such postings when 24 25 appropriate, but in no event shall the postings be left up for more than thirty (30) days. All 26 materials placed on the designated bulletin boards shall bear the date of posting and may be 27 removed by the University after having been posted for a period of thirty (30) days. In addition, 28 such bulletin boards may not be used for election campaigns for public office or exclusive 29 collective bargaining representation.
- 30 Communication. UFF shall have the right to send communications to their members or 4.6 31 prospective members at their University email accounts for communications relevant to UFF's 32 status as a collective bargaining agent. The University has no obligation to provide UFF or its 33 agents with a University email account or to create or provide UFF with access to various 34 University email lists.
